**Skills and experience:** Mrs. Paatashvili, as an international healthcare specialist, supports different projects in health policy and public health worldwide. She started her career in 2000, at the Ministry of Labour, Health and Social Affairs of Georgia where she worked till 2013 and gained vast professional and leadership experience in the areas of health policy, regulations, quality and capacity building, financing, procurements and state program management. Eka was a member of numbers of government committees and work groups where successfully collaborated with multiple stakeholders and she participated in decision-making. She actively participated in planning and implementing the reforms of Georgia health system.
